BE IT ENACTED BY THE QUORUM COURT OF CLEBURNE COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED: AN APPROPRIATION ORDINANCE AMENDING ORDINANCE NO. 2017-023, WHICH ADOPTED THE BUDGET FOR THE CALENDAR YEAR 2018 AND/OR OTHER PURPOSES, TO AMEND THE 2018 COUNTY ROAD BUDGET

WHEREAS, need exist to amend the 2018 County Road Budget to appropriate funds to create a line item for the purchase of land,

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF CLEBURNE COUNTY:

Section 3. All Ordinances and parts of Ordinances in conflict herewith are hereby repealed to the extent of such conflict.

EMERGENCY CLAUSE

The Quorum Court hereby finds and determines an immediate appropriation to the County Road Budget is required to resolve this issue and protect the financial integrity of County Government, therefore, an emergency is hereby declared to exist, and this Ordinance, being necessary for the preservation of the public peace, health, and safety shall be in effect from and after its passage and approval.
