CLEBURNE COUNTY QUORUM COURT JOURNAL OF PROCEEDINGS

April 10, 2025

The Cleburne County Quorum Court met in regular session in the Cleburne Court Building, 922 South 9th Street, Heber Springs, Arkansas. The meeting was called to order at 6:03 p.m. County Judge Eric Crosby presided.

PRESENT: Moorehead, Henegar, Beavers, Fletcher, Malone, Evans, Martin, Foust, Tamburo, Baugh, McClung.

ABSENT: None.

READING, CORRECTION, AND DISPOSITION OF MINUTES:

Motion was made by JP Fletcher to approve the minutes of March 13, 2025, regular meeting, seconded by JP Martin. Voice vote, motion carried.

REPORT OF TREASURER:

Motion was made by JP Malone to accept the Treasurer's report, seconded by JP Moorehead. Voice vote, motion carried.

REPORT OF COMMITTEES:

Emergency Services Oversight Committee: JP Foust said the dispatch report format was discussed. There have been more volunteers added throughout the county. All tornado sirens in the county are working except in Wilburn. There is an ordinance to be voted on to be added to the agenda concerning purchasing burn buildings.

Budget Committee: JP Evans stated that the next meeting will include 2024 anticipated revenue compared to actual revenue and moving money to capital outlay. Prim and Pine Snag Lobo requested funds for equipment, met the requirements listed in Ordinance 2022-036, and was approved.

Jail Committee: JP Evans said the jail committee has met with SouthBuild for a whiteboard session. The proposal will be sent to the state before proceeding.

BE IT ENACTED BY THE QUORUM COURT OF CLEBURNE COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED: "AN APPROPRIATION ORDINANCE AMENDING ORDINANCE NO. 2024-42, WHICH ADOPTED THE BUDGET FOR CALENDAR YEAR 2025 AND/OR OTHER PURPOSES TO AMEND THE OEM BUDGET."

WHEREAS, need exists to increase the budget of Office of Emergency Management (OEM) to purchase two Burn Buildings to be used for Fire Department and EMS training.

PROPOSED RESOLUTION NO. 2025-911 CREDIT CARD

A RESOLUTION FOR THE PURPOSE OF AUTHORIZING THE ISSUANCE OF ONE CREDIT CARD TO BE USED EXCLUSIVELY IN THE NORMAL COURSE OF BUSINESS BY CLEBURNE COUNTY EMERGENCY 911

BE IT HEREBY RESOLVED by the Quorum Court of Cleburne County, Arkansas as follows:

WHEREAS, the maximum limit on this credit card will not exceed \$4,000 and the payment of any outstanding balances will be paid in full monthly. The monthly billing statements will be mailed to the Cleburne County Emergency 911's Office for the appropriate disposition of any outstanding balances, and

WHEREAS, the credit card will be issued through First Security Bank and the resulting credit extended will be guaranteed and paid by the Cleburne County Treasurer, and

WHEREAS, the agreement seems to be in the best interest of the Cleburne County Emergency 911 of Cleburne County, Arkansas.

NOW, THEREFORE, BE IT RESOLVED BY THE CLEBURNE COUNTY QUORUM COURT that the Cleburne County Emergency 911 is hereby authorized to enter into agreement with First Security Bank as set out above.
