

ORDINANCE NO. 2026-04

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF CLEBURNE, STATE OF ARKANSAS: AN ORDINANCE TO BE ENTITLED: APPROPRIATION ORDINANCE AMENDING ORDINANCE NO. 2025-023, WHICH ADOPTED THE BUDGET FOR THE CALENDAR YEAR 2026 AND FOR OTHER PURPOSES.

WHEREAS, need exist for the improvement of the Cleburne County Jail, and

WHEREAS, need exist to establish a Jail Construction Fund for the aforementioned purpose; and

WHEREAS, need exist to appropriate funds to establish the Jail Construction 2026 Fund;

Section 1. The following appropriation is hereby approved:
