The Cleburne County Quorum Court met in regular session in the Cleburne Court Building, 922 South 9th Street, Heber Springs, Arkansas. The meeting was called to order at 6:03 p.m. County Judge Eric Crosby presided.

**PROPOSED ORDINANCE NO. 2026-AMEND COURTHOUSE MAINTENANCE AND CLEBURNE COUNTY
FAIR BUDGETS**

**BE IT ENACTED BY THE QUORUM COURT OF CLEBURNE COUNTY, STATE OF ARKANSAS, AN
ORDINANCE TO BE ENTITLED: AN APPROPRIATION ORDINANCE AMENDING ORDINANCE NO. 2025-
023 WHICH ADOPTED THE BUDGET FOR THE CALENDAR YEAR 2026 AND/OR OTHER PURPOSES**

WHEREAS, private donations received by the Cleburne County Treasurer need to be appropriated through the Cleburne County Fair budget; and

WHEREAS, Cleburne County has been awarded a reimbursement grant for elevator replacement expenses;
