

# CLEBURNE COUNTY QUORUM COURT JOURNAL OF PROCEEDINGS

May 11, 2017

The Cleburne County Quorum Court met in regular session in the County Court Building, 922 South 9<sup>th</sup> Street, Heber Springs, Arkansas. The meeting was call to order at 6:02 p.m. County Judge Jerry Holmes presided. Roll call was taken. PRESENT: Henegar, Caldwell, Stone, Evans, Lange, Roberts, Goff. ## READING, CORRECTION, AND DISPOSITION OF MINUTES:

Motion was made by JP Caldwell to approve the minutes of the April 13, 2017 regular meeting, seconded by JP Lange. Voice vote, motion carried unanimously.
