

A RESOLUTION AUTHORIZING CONTRACT WITH WASTE CONNECTIONS OF ARKANSAS, INC. TRANSFER STATION INCLUDING NEW FEE SCHEDULE

WHEREAS, Cleburne County wishes to enter into a binding contract with Waste Connections of Arkansas, Inc. for a duration of ten (10) years and said contract requires the Cleburne County Quorum Court consider reasonable and appropriate increase in fees upon completion of the new scale system; and

WHEREAS, Waste Connections of Arkansas, Inc. is requesting a new fee schedule based on the availability of being able to weigh trash per ton with the new proposed scale equipment.

BE IT HEREBY RESOLVED by the Quorum Court of Cleburne County, Arkansas, as follows:

Section 1: The Quorum Court of Cleburne County herein approves the County Judge to sign and execute the new contract with Waste Connections of Arkansas, Inc.

Section 2: These current fees, which were imposed in Cleburne County Resolution 2014-002, shall remain in place at this time and stay in place until the new weighing scale system is operational which will then activate the cost fee structure pursuant to Section 3. If the new weighing system becomes inoperable or malfunctioning, then it is approved that Waste Connections of Arkansas, Inc. shall be allowed to continue to take waste pursuant to the fee schedule under Cleburne County Resolution 2014-002.

Section 3: Upon completion of the new scale system, the Cleburne County Quorum Court hereby approves the following new contract waste disposal fee structure:


- \$1.28 per less than thirty-three (33) gallon trash bag up to twenty (20) bags and over twenty (20) bags is a minimum of thirty-five (\$35) dollars up to 1,000 lbs;
- \$2.04 per thirty-three (33) gallon trash bag up to ten (10) bags and over ten (10) bags is a minimum of thirty-five (\$35) dollars up to 1,000 lbs;
- \$3.57 per contractor trash bag up to ten (10) bags and over ten (10) bags is a minimum of thirty-five (\$35) dollars up to 1,000 lbs;
- \$35.00 per load for less than 1,000 lbs of trash;
- \$75.00 per ton for more than 1,000 lbs of trash;
- \$90.00 per ton for shingles

NOW, THEREFORE, IT IS RESOLVED that the Quorum Court of Cleburne County, Arkansas, hereby declares that the County Judge be authorized to execute any documents necessary to effect this contract approval, and the Quorum Court also approves the additional fee structure as described both in this resolution and in said contract.


