

**ORDINANCE NO. 2020-005**

**BE IT ENACTED BY THE QUORUM COURT OF CLEBURNE COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED: "AN APPROPRIATION ORDINANCE AMENDING ORDINANCE NO. 2019-020, WHICH ADOPTED THE BUDGET FOR THE CALENDAR YEAR 2020 AND/OR OTHER PURPOSES TO AMEND PERSONAL SERVICES, AND AMENDING ORDINANCE 2019-019 ESTABLISHING THE NUMBER OF EMPLOYEES AND AUTHORIZED SALARY PER EMPLOYEE FOR EACH DEPARTMENT OF THE CLEBURNE COUNTY GOVERNMENT".**

**WHEREAS**, need exists to amend the 2020 Number of Employees and Authorized Salary per Employee in the Department of District Court, and

**WHEREAS**, need exists to amend the 2020 Budget for salary change in the District Court Budget.




