

ORDINANCE NO. 2023-13

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF CLEBURNE, STATE OF ARKANSAS; AN ORDINANCE TO BE ENTITLED: "AN APPROPRIATION ORDINANCE AMENDING ORDINANCE NO. 2022-040, WHICH ADOPTED THE BUDGET FOR THE CALENDAR YEAR 2023 AND FOR OTHER PURPOSES TO AMEND THE UNEMPLOYMENT COMPENSATION LINE ITEM.

WHEREAS, Cleburne County paid a premium pay in January of 2023, and

WHEREAS, the Unemployment Compensation line item was inadvertently overlooked in the appropriation for the premium pay, and

WHEREAS, need exists to amend the 2023 Budget to correct this error.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF CLEBURNE COUNTY, ARKANSAS:

Section 1. The following appropriations are hereby approved to increase Line Item 1011- Unemployment Compensation in the following 2023 Budgets by the amount listed:
