

CLEBURNE COUNTY QUORUM COURT JOURNAL OF PROCEEDINGS

December 11, 2025

The Cleburne County Quorum Court met in regular session in the Cleburne Court Building, 922 South 9th Street, Heber Springs, Arkansas. The meeting was called to order at 6:00 p.m. County Judge Eric Crosby presided.

READING, CORRECTION, AND DISPOSITION OF MINUTES:

Motion was made by JP Martin to approve the minutes of November 20, 2025, regular meeting, seconded by JP Baugh. Voice vote, motion carried.

REPORT OF TREASURER:

Motion was made by JP Fletcher to accept the Treasurer's report, seconded by JP Martin. Voice vote, motion carried.

REPORT OF COMMITTEES:

Proposed Ordinance No. 2025-Update Traffic Ordinance

Voice vote, motion carried. JP Malone made a motion to adopt the Ordinance, seconded by JP Evans. Roll Call was taken.
