

ORDINANCE NO. 2021-017

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF CLEBURNE, STATE OF ARKANSAS; AN ORDINANCE TO BE ENTITLED: "AN APPROPRIATION ORDINANCE AMENDING ORDINANCE NO. 2020-032, WHICH ADOPTED THE BUDGET FOR THE CALENDAR YEAR 2021 AND/OR OTHER PURPOSES".

WHEREAS, need exists to appropriate \$2,550.00 into the Local Law Enforcement Equipment Grant Fund budget. 
Section 3. All Ordinances and parts of Ordinances in conflict herewith are hereby repealed to the extent of such conflict.
