

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF CLEBURNE, STATE OF ARKANSAS; AN APPROPRIATION ORDINANCE TO BE ENTITLED: "APPROPRIATION ORDINANCE AMENDING ORDINANCE NO. 2018-026, WHICH ADOPTED THE BUDGET FOR THE CALENDAR YEAR 2019 AND FOR OTHER PURPOSES, RENAMING THE BOATING SAFETY FUND AND ESTABLISHING A 2019 BUDGET FOR THE COUNTY EMERGENCY RESCUE FUND."

WHEREAS, the need exists to change the name of the Boating Safety Fund to the County Emergency Rescue Fund due to the Sheriff's Office no longer having water patrol on the waterways within Cleburne County.

Section 3. All Ordinances and parts of Ordinances in conflict herewith are hereby repealed to the extent of such conflict.


