The Little Rock Vet Center has a Mobile Vet Center (MVC) to provide outreach to the veterans in your county. The MVC resembles a super-sized recreational vehicle; it is 38 foot long and 13 foot 6 inches tall. The mission of the Readjustment Counseling Services is to provide information to Veterans in far-reaching rural areas on the services the Little Rock Vet Center has to offer. They are as followed: Individual Readjustment counseling, Group counseling. Military Sexual Trauma counseling, Bereavement counseling, Marital and Family counseling, Referrals, Substance Abuse Information and Referral, Community Education and Liaison with Community Agencies.
