BE IT ENACTED BY THE QUORUM COURT OF CLEBURNE COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED: AN APPROPRIATION ORDINANCE AMENDING ORDINANCE NO. 2018-026, WHICH ADOPTED THE BUDGET FOR THE CALENDAR YEAR 2019 AND/OR OTHER PURPOSES TO AMEND THE ELECTION COMMISSION BUDGET AND THE COUNTY CLERK BUDGET.

WHEREAS, the cost of the Odd Year Confirmation Mailing is considerably more than originally expected, and therefore, an additional increase is required for the County Clerk's Budget for year 2019 to comply with the Odd Year Confirmation Mailing,

Section 3. All Ordinances and parts of Ordinances in conflict herewith are hereby repealed to the extent of such conflict.


