

ORDINANCE NO. 2020-003

BE IT ENACTED BY THE QUORUM COURT OF CLEBURNE COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED: "AN APPROPRIATION ORDINANCE AMENDING ORDINANCE NO. 2019-020, WHICH ADOPTED THE BUDGET FOR THE CALENDAR YEAR 2020 AND/OR OTHER PURPOSES TO AMEND PERSONAL SERVICES, AND AMENDING ORDINANCE 2019-019 ESTABLISHING THE NUMBER OF EMPLOYEES AND AUTHORIZED SALARY PER EMPLOYEE FOR EACH DEPARTMENT OF THE CLEBURNE COUNTY GOVERNMENT".

WHEREAS, need exists to amend the 2020 Number of Employees and Authorized Salary per Employee in the Department of the County Clerk, and

WHEREAS, need exists to amend the 2020 Budget for salary change in the County Clerk Budget.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF CLEBURNE COUNTY:


