**BE IT ENACTED BY THE QUORUM COURT OF CLEBURNE COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED: AN APPROPRIATION ORDINANCE AMENDING ORDINANCE NO. 2017-21, 2017-22 AND 2017-023, WHICH ADOPTED THE POSITIONS AND THE BUDGET FOR THE CALENDAR YEAR 2018 AND/OR OTHER PURPOSES, TO AMEND THE 2018 SHERIFF'S OFFICE AND DETENTION CENTER BUDGET AND THE QUORUM COURT BUDGET**




