READING, CORRECTION, AND DISPOSITION OF MINUTES:

Motion was made by JP Evans to approve the corrected minutes of August 14, 2025, regular meeting, seconded by JP Fletcher. Voice vote, motion carried.

REPORT OF TREASURER:

Motion was made by JP Martin to accept the Treasurer's report, seconded by JP Fletcher. Voice vote, motion carried.

REPORT OF COMMITTEES:

Emergency Services Oversight Committee: JP Martin reported discussion from last meeting included tornado shelters throughout county. Lengthy discussion about the dispatch report and possible changes to adjust how lift assists are shown followed.

Budget Committee: JP Evans stated the Budget Committee and Jail Committee Meetings were combined in August. Discussion included space options, although this issue is not as great of demand as previously thought, jail plans, 2026 budget meeting. Anticipated Revenue Meeting will be October 8 and 2026 Budget Meeting will be October 27.

NEW BUSINESS:

Proposed Ordinance No. 2025-2025 Budget

JP Evans introduced an Ordinance. "BE IT ENACTED BY THE QUORUM COURT OF CLEBURNE COUNTY, ARKANSAS, AN ORDINANCE TO BE ENTITLED: " AN APPROPRIATION ORDINANCE AMENDING ORDINANCE NO. 2024-42 WHICH ADOPTED THE BUDGET FOR CALENDAR YEAR 2025 AND /OR OTHER PURPOSES TO AMEND CERTAIN DEPARTMENTS BUDGETS." JP Evans made a motion to adopt the Ordinance, seconded by JP Moorehead. JP Henegar made a motion to strike the first "Whereas":

WHEREAS, Cleburne County has need to for the Treasurer to transfer from the County Clerk's Cost Fund 3005-0101, \$10,000.00 to County General 1000-101 to complete transfer left off Ordinance 2025-10 in error, seconded by JP Evans. Voice vote, motion carried, first "Whereas" is stricken. JP Fletcher made a motion to add to second "Whereas":

WHEREAS, Cleburne County has need to make corrections in line items used in error in County Clerk and Election's budgets, to list the Assessor and Coroner. JP Fletcher withdrew motion. JP Fletcher made a motion to take all names listed out of the second "Whereas". JP Fletcher withdrew motion. JP Fletcher made another motion to amend second "Whereas" and withdrew motion. Roll Call was taken. Ayes: Baugh, Beavers, Evans, Fletcher, Foust, Henegar, Martin, McClung, Moorehead, Tamburo. Nays: None. Absent: Malone.

Passed and adopted as Ordinance 2025-16.

Proposed Resolution No. 2025-A Resolution authorizing the County Judge to enter into an agreement with White River Planning and Development District, Inc.

JP Foust introduced a Resolution. **"A RESOLUTION AUTHORIZING THE COUNTY JUDGE OF CLEBURNE COUNTY, ARKANSAS, TO ENTER INTO AN ADMINISTRATIVE AGREEMENT WITH THE WHITE RIVER PLANNING AND DEVELOPMENT DISTRICT, INC."** JP Foust made a motion to adopt the Resolution, seconded by JP Martin. Roll Call was taken. Ayes: Baugh, Beavers, Evans, Fletcher, Foust, Henegar, Martin, McClung, Moorehead, Tamburo. Nays: None. Absent: Malone.

Passed and adopted as Resolution 2025-07.

Proposed Resolution No. 2025-A Resolution authorizing Chief Elected Officer to sign an application for CDBG Funds JP Foust introduced a Resolution. **"BE IT RESOLVED BY THE QUORUM COURT OF CLEBURNE COUNTY STATE OF ARKANSAS, A RESOLUTION TO BE ENTITLED: A RESOLUTION AUTHORIZING THE SUBMITTAL OF AN APPLICATION FOR ACEDP GRANT FUNDS TO THE STATE OF ARKANSAS FOR ADA IMPROVEMENTS TO COURTHOUSE."** JP Foust made a

motion to adopt the Resolution, seconded by JP Martin. Roll Call was taken. Ayes: Baugh, Beavers, Evans, Fletcher, Foust, Henegar, Martin, McClung, Moorehead, Tamburo. Nays: None. Absent: Malone

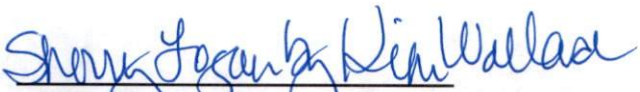
