### ANNUAL SCHOOL ELECTION

May 9, 2023

The Board of Election Commissioners of Cleburne County, Arkansas, pursuant to Arkansas Code 7-5-202 (a)(1) (A-H), and (2)(B), Act 448 of 2021, do hereby proclaim that a Nonpartisan and Annual School Election will be held in Cleburne County, Arkansas on Tuesday, May 9, 2023.

### EARLY VOTING

Early voting will be available May 2 – May 8, 2023 (closed on Saturday and Sunday). Voting times are Monday-Friday, 8:30 a.m. to 4:30 p.m. Early voting ends at 4:30 p.m. Monday, May 8, 2023. Early voting will be held at the Cleburne County Courthouse, 301 West Main Street, Heber Springs, Arkansas.

### ELECTION DAY VOTING

The election will be held between the hours of 7:30 a.m. and 7:30 p.m. on May 9, 2023. All eligible voters in Cleburne County will be able to cast their vote at any Vote Center listed below:

#### **Heber Springs School District**

The total rate proposed includes the uniform rate of tax (the "Statewide Uniform Rate") to be collected on all taxable property in the State and remitted to the State Treasurer pursuant to Amendment No. 74 to the Arkansas Constitution to used for maintenance and operation of schools in the State. As provided in Amendment No. 74, the Statewide Uniform Rate replaces a portion of the existing rate of tax levied by this School District and available for maintenance and operations in this District. The total proposed school tax levy of 32.8 mills include 25.0 mills specifically voted for general maintenance and operation and 7.8 mills voted for debt service previously voted as a continuing levy pledged for the retirement of existing bond indebtedness. The District may use the surplus revenues produced each year by debt service millage for other school purposes. The total proposed school tax levy of 32.8 mills represents the same tax rate presently being collected.

Ballot and election results will be processed, canvassed, and counted at 7:30 p.m. on May 9, 2023, at the Cleburne County Courthouse. Absentee ballot outer envelopes will be opened and processed at the Cleburne County Courthouse, May 9, beginning at 10:00 a.m.

An objection to the service of an elected official, deputy county clerk, or additional deputy must be filed with the Election Commission by May 9, 2023 at the Cleburne County Clerk's office.
