# **CLEBURNE COUNTY QUORUM COURT JOURNAL OF PROCEEDINGS**

December 14, 2023

The Cleburne County Quorum Court met in regular session in the Cleburne Court Building, 922 South 9<sup>th</sup> Street, Heber Springs, Arkansas. The meeting was called to order at 6:02 p.m. County Judge Eric Crosby presided.

PRESENT: Moorehead, Henegar, Caldwell, Fletcher, Malone, Evans, Martin, Foust, Tamburo, Owens. ABSENT: Wildmon

#### READING, CORRECTION, AND DISPOSITION OF MINUTES:

Motion was made by JP Martin to approve the minutes of the November 16, 2023, regular meeting as corrected, seconded by JP Malone. Voice vote, motion carried.

#### REPORT OF TREASURER:

Motion was made by JP Caldwell to accept the Treasurer's report, seconded by JP Foust. Voice vote, motion carried.

#### **REPORT OF COMMITTEES:**

Emergency Services Oversight Committee: JP Foust reported that Survival Flight will be requesting a rate increase on the County contract, but the Committee will need to speak with the County Attorney. This increase will be discussed at the January 2024 meeting. The committee voted that Judge Crosby/Amanda reach out requesting that all volunteer Fire and EMS send an updated list of board members and contact information. The committee also discussed the early activation protocol and voted to leave the protocol unchanged. Future meetings for 2024 are planned for the third Tuesday of each month at 10:00 a.m. at the Judge's office. The ESOC would like to meet with the City of Heber officials to discuss ambulance placement possibly at the Road Department.

<u>Budget Committee</u>: JP Evans reported the next meeting is December 18, 2023. The main topic will be the Cleburne County Aging program and building. The jail will also be discussed. The 2023 Jail report was received and filed.

Judge Crosby reported from the 2022 Legislative Audit that "No issues came to our attention that we considered necessary to report to management."

Judge Crosby reported that thanks to Rebekah Knew, County Judge Administrative Assistant, in the last couple of years through the Judge's office, nearly \$14 million has been applied for and was granted in broadband grants for the county. However, there are still several large areas that do not have broadband. In 2024 The State of Arkansas will receive close to \$1 billion to help fund this project. They will be looking at the FCC map as to where this funding needs to be placed. It is imperative that if you don't see work being done to please contact the Judge's office so this information can be forwarded to the State.

#### PROPOSED ORDINANCE NO: 2024-AMEND ORDINANCE 2021-029

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY CLEBURNE, STATE OF ARKANSAS: AN ORDINANCE TO BE ENTITLED: "AN ORDINANCE TO AMEND ORDINANCE 2021-029 ADOPTING THE SHERIFF'S OFFICE PAY SCALE AND COMPENSATION FOR DUTIES".

WHEREAS, in November of 2021, the Cleburne County Quorum Court passed Ordinance 2021-029, setting the pay structure and rank structure for the Sheriff's Office,

WHEREAS, there is now need to amend it to reflect current needs and best practices

# THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF CLEBURNE COUNTY, ARKANSAS

Section 1. Section 3 of Ordinance 2021-029 shall be amended to read as follows:

Section 3. Effective January 1<sup>st</sup>, 2024, the starting pay for a detention officer will be \$30,188 and will increase any time the Quorum Court chooses to raise starting pay, such as during budget time each year.

Stipend Pay for additional duties: Cleburne County Sheriff's Office Detention Officers in the following designated positions shall receive in addition to their current pay the following additional compensation for assigned duties. The following additional pay shall be prorated annually such that the employee shall receive said pay for so long as they are in the assigned position. Deputies have no property rights in these positions and serve at the will of the Sheriff in these assigned positions.

#### Stipend Amounts:

JAIL ADMINISTRATOR (CAPTAIN), current pay plus \$7,000;

DETENTION CENTER LIEUTENANT, current pay plus \$2,000;

DETENTION CENTER SERGEANT, current pay plus \$1,000;

DETENTION CENTER CORPORAL, current pay plus \$750;

DETENTION OFFICER/MEDICAL ASSISTANT, current pay plus:

\$1,000 for CNA/Med Tech/Med Asst/Patient Care Tech/or equivalent \$2,500 for LPN/RN/APN/NP/or equivalent.

<u>Section 2</u>. In the event that any provision of this Ordinance or the application thereof to any person or circumstance is held to be invalid, such invalidity shall not affect the other provisions or applications to this Ordinance which can be given effect without the invalid provision or application, and to this end, the provisions of this Ordinance are declared to be severable.

Section 3. All Ordinances and parts of Ordinances in conflict herewith are hereby repealed to the extent of such conflict.

Section 4 Emergency Clause. The Quorum Court hereby finds and determines an immediate clarification of County policy is required to resolve this issue and protect the financial integrity of County Government; therefore, an emergency is hereby declared to exist and this Ordinance being necessary for the preservation of the public peace, health and safety shall be in effect from and after its passage and approval.

# A RESOLUTION AUTHORIZING A NEW FEE SCHEDULE WITH WASTE CONNECTIONS TRANSFER STATION

**WHEREAS**, Cleburne County wishes to authorize a new fee schedule with Waste Connections Transfer Station.

BE IT HEREBY RESOLVED by the Quorum Court of Cleburne County, Arkansas, as follows:

<u>Section 1</u>. Due to the increase of 8.57% in the annual consumer price index for 2024, Waste Connections Transfer Station is requesting an increase in the transfer station rates as provided in their contract under section 11. The increase in the transfer station rates and the increase in cost per ton are equal, as required by the contract.

Section 2. The Cleburne County Quorum Court hereby approves the following waste disposal fee structure:

Less than thirty-three (33) gallon trash bag \$1.51; Thirty-three (33) gallon bag \$2.40; Contractor bag \$4.20; Percentage of a ton(s) at \$88.11 per ton; \$105.73 per ton for shingles

NOW, THEREFORE, IT IS RESOLVED that the Quorum Court of Cleburne County, Arkansas, approves the new fee structure as described in this resolution.
