

# CLEBURNE COUNTY QUORUM COURT JOURNAL OF PROCEEDINGS

June 10, 2021

The Cleburne County Quorum Court met in regular session in the County Court Building, 922 South 9<sup>th</sup> Street, Heber Springs, Arkansas. ## READING, CORRECTION, AND DISPOSITION OF MINUTES:

Motion was made by JP Caldwell to approve the minutes of the May 13, 2021, regular meeting, seconded by JP Martin. Voice vote, motion carried.

### Proposed Ordinance No. 2021-Traffic Ordinance
