BE IT ENACTED BY THE QUORUM COURT OF CLEBURNE COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED: AN APPROPRIATION ORDINANCE AMENDING ORDINANCE NO. 2017-021, ORDINANCE 2017-022, AND ORDINANCE 2017-023, WHICH ADOPTED THE BUDGET FOR THE CALENDAR YEAR 2018 AND/OR OTHER PURPOSES, TO ADD A DEPUTY CLERK'S POSITION IN THE OFFICE OF CIRCUIT CLERK.

Section 1. The following appropriations are hereby approved:




