

**ORDINANCE NO. 2018-030**

**BE IT ENACTED BY THE QUORUM COURT OF CLEBURNE COUNTY, STATE OF ARKANSAS, AN APPROPRIATION ORDINANCE TO BE ENTITLED: AN APPROPRIATION ORDINANCE AMENDING ORDINANCE NO. 2017-023, WHICH ADOPTED THE BUDGET FOR THE CALENDAR YEAR 2018 AND/OR OTHER PURPOSES, TO AMEND THE 2018 COUNTY CLERK BUDGET AND AMEND THE RECORDER'S COST BUDGET.**

**WHEREAS**, need exists to amend the 2018 County Clerk Budget to appropriate funds to increase the part-time salaries and decrease the Overtime and Other Premium Compensation line items, and

**WHEREAS**, need exists to amend the 2018 Recorder's Cost Budget to appropriate funds to increase the Non-Contributory Retirement line item and decrease the Computer Software, Support and Maintenance Agreement line items.




**Section 3.** All Ordinances and parts of Ordinances in conflict herewith are hereby repealed to the extent of such conflict.
