**Agreement:**

- A. Vendor, their employees, and other representatives will comply with the rules and regulations of Revive Heber Springs. (RHS)
- B. All installations erected by the vendor shall be subject to the approval of RHS.
- C. Vendor shall not transfer or subject the space or any part thereof or permit the same to be used by any other person without the prior written consent of RHS.
- D. Vendors will keep exhibits open throughout the entire event and shall not dismantle before the official end of the event without prior approval of RHS.
- E. Wide selections or unusual menus are encouraged. Any new items must be approved by the festival committee to avoid duplication of returning vendors.

**Vendor Agreement:**

- A. Vendor hereby indemnifies RHS for any and all expenses, judgements, attorneys fees, or any cost of any nature

whatsoever resulting from any liability for any reason resulting for the vendors sales at the event.

- B. Vendors shall be responsible for the cleanup and removal of all trash and debris brought to the event as a result of the sales of the vendor.
- C. Multi-vendor agrees to pay \$400 flat fee and single item vendor agrees to pay \$200 flat fee to The Heber Springs Area Chamber Foundation with Revive in the memo line. Payment must accompany application. RHS will determine placement of the vendor.
- D. RHS will allow one vehicle on the premises for supply purposes. Vendor agrees to contact RHS upon arrival to sign in, receive packet and parking instructions.

A copy of insurance assignment and Arkansas Department of Health approval and copy of tax ID number must accompany this signed agreement.

**Application and Payment deadline -June 1st.**

The management of RHS, the City, or County shall be responsible or liable for fire, theft, or breakage, whether caused by negligence, willfully or otherwise.
