

ORDINANCE NO. 2018-007

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF CLEBURNE, STATE OF ARKANSAS: AN ORDINANCE TO BE ENTITLED: AN APPROPRIATION ORDINANCE AMENDING ORDINANCE NO. 2017-023, WHICH ADOPTED THE BUDGET FOR THE CALENDAR YEAR 2018 AND/OR OTHER PURPOSES.

WHEREAS, need exists to appropriate \$3,000.00 into the First Responder Grant Fund budget. The Sheriff's Department has applied for and received a Diamond Pipeline First Responder Grant in the amount of \$3,000.00. Said grant was awarded after the budget process and must be appropriated.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF CLEBURNE COUNTY, ARKANSAS:

Section 1. The First Responder Grant fund budget is hereby amended as follows:


Section 2. Section 3. All Ordinances and parts of Ordinances in conflict herewith are hereby repealed to the extent of such conflict.

The Quorum Court hereby finds and determines an immediate clarification of County Policy is required to resolve this issue and protect the financial integrity of County Government; therefore, an emergency is hereby declared to exist and this Ordinance being necessary for the preservation of the public peace, health, and safety shall be in effect from and after its passage and approval.
